

WAYS FOR AMERICANS TO DONATE TO SUPPORT ICFC PROJECTS

KEY POINTS

- Americans can donate to ICFC projects through Myriad USA (formerly called King Baudouin Foundation US), a US 501(c)3 non-profit that since 1997 has facilitated cross-border philanthropy.
- Online donations to Myriad in support of ICFC projects are handled by www.every.org
- Donors will receive a donation receipt for the full amount of their donation.
- The full donation made by donors is applied to the project(s) as all administrative costs are covered by some core donors.
- ICFC will confirm that your donation has been applied to the project as requested.

Check

Make your check payable to Myriad USA.

Donor Advised Funds

Bequests

You can bequeath a specific dollar amount, property to be sold, or a percentage of your residual estate to Myriad USA for the benefit of one of the **ICFC - Tropical Conservation Fund**. Life insurance policies

You can name the **ICFC - Tropical Conservation Fund** hosted at Myriad USA as the beneficiary of an existing life insurance policy that is no longer needed to provide for dependents. While the value of the policy will be included in your estate, an offsetting estate tax charitable deduction will be allowed. Retirement plan assets
